Summary: Safya is an economic historian whose research lies in the intersection of the historical-political-economy discourse. Her journal publications have focussed on state capacity in Mughal South Asia, with comparisons of Eurasian empires. Her monograph which is currently under discussion with *Cambridge University Press*, studies the relationship between the Mughal state and the local elite through the lens of conflict. She is currently employed as a Research Associate on an ERC funded project researching how globalisation affected institutional change in Asia and Africa. Her research has won multiple awards, including the Gino Luzzatto Dissertation Prize 2023 and the Economic History Society Poster Prize 2021. She aspires to build deep, interconnected histories of the Eurasian continent.
